- New immigrants mentioned above who are divorced from their spouses or whose spouses are deceased but who are eligible by laws and regulations for continued residence and work in Taiwan area

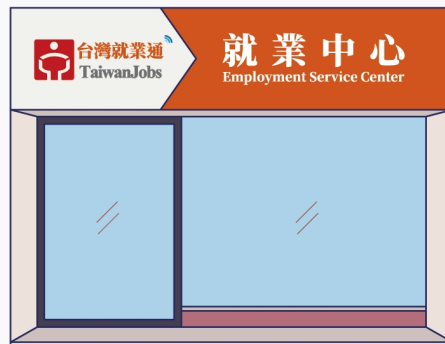

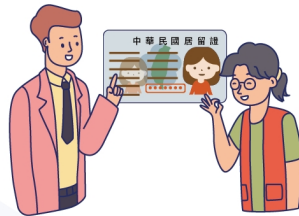
Tips of Employment Services

Tip 1 Employment Services



TaiwanJobs
job.taiwanjobs.gov.tw

- New immigrants can bring valid ARC to public employment service centers for individualized services.
- Use TaiwanJobs website for job opportunities, vocational training courses, and job fairs.



Tip 2 Vocational Training



Pre-service training

- Free vocational training for unemployed new immigrants
- Living allowance at 60% of basic wage for new immigrants enrolled in the vocational training



Tip 3 Startup Assistance

- Free startup classes and consultation service provided by the government

Tip 4 Skill Test Assistance

- New immigrants may, when taking national technician skill tests, request to have some test items presented in Mandarin in sound tracks.
- New immigrants with specific status and being qualified for participating in various categories of tests may apply for subsidies on the fees of written test, technical test, registration qualification review, and the license issuance when taking the skill tests.



Employment Promotion Subsidies



What employment subsidies are available for new immigrants?



Temporary Work Allowance : At basic hourly wage rate, with the total not exceeding the basic monthly wage rate, for a maximum of 6 months



Job Training and Readjustment Program

Subsidies : At basic hourly wage rate, with the total not exceeding the basic monthly wage rate, for a maximum of 3 months



Subsidies for the Labor Shortage, the Resident Care Attendants, and the Construction

Industries: NT\$5,000 to NT\$7,000 per month at the maximum of NT\$108,000 (sum of these three categories), for a maximum of 18 months



What subsidies are available to employers of new immigrants?



Hiring Subsidy and Award : NT\$11,000 per month (monthly-paid employee) or NT\$60 per hour (non-monthly-paid employee) per person as hired by the same employer for a maximum of 12 months



Management and Consultation Subsidy to the Employers : NT\$5,000 per month or 30% of the actual job training and readjustment subsidies, for a maximum of 3 months
