Note:

- 1. Quarantine hotels and government quarantine facilities follow the "one person per room" rule.
 - (1) Family members/people in the same household arriving on the same day can share a room (depending on their willingness and the room type).

 (2) Single rooms are not recommended for more than two adults.
- 2. People who shared a room at quarantine hotels/ facilities can share a room at home.

3. Fully vaccinated for 14 days

- (1) Children under the age of 12 are seen as unvaccinated.
- (2) The vaccination status of children under the age of 12 follows that of the accompanying adult inbound passenger.

4. Home quarantine rules

- (1) One person per residence (the inbound passenger is in a residence where nobody not undergoing
- (2) One person per room (sharing residence with people not undergoing quarantine in a separate room)

Note:

- 1. Passengers who are unable to obtain a PCR test result should print out and fill in the "Entry Quarantine Affidavit When a Traveler Is Unable to Present a COVID-19 RT-PCR Test Report Prior to Boarding."
- 2. (1) Visit the Tourism Bureau's "Epidemic Prevention Quarantine Hotels" website to book your quarantine hotel in cities/counties where there is still capacity: https://taiwan.taiwanstay.net.tw/covhotel/
 - (2) Those who cannot fill in the declaration online due to specific circumstances should print out and fill in the "Quarantine Residence Affidavit for Travelers Entering Taiwan."
- 3. Inbound passengers who cannot show proof of full vaccination must choose Program A or B, with the exception of those under 12 years old.

^{*} In accordance with Article 58 of the Communicable Disease Control Act, inbound passengers are required to make truthful declarations and have all the documents ready. Any refusal, evasion, obstruction or untruthful declaration could result in a fine of up to NT\$150,000 and potential criminal liability.

Note

- 1. Follow the health authority's instructions to take the PCR test in the designated location.
- 2. Inbound passengers should report their government-sponsored rapid test results to their borough chief on the phone during the quarantine period and report their government-sponsored rapid test results via text message during their self health management period.
- 3. Report the self-paid rapid test results of people in the same household for the 7+7+7 program via text message.
- 4. If the result of an at-home test is positive, please follow the instructions of your local health authority on further testing and contact tracing measures.
- 5. Any violation of relevant quarantine regulations can result in a fine of up to NT\$1 million.

Appendix - Enhanced/Self-Health Management Regulations

Enhanced self-health management for people in the same household

Besides the self-health management regulations on the right, people should abide by the following regulations:

Don't share a room or bathroom with the person in quarantine. The parties are not allowed to be in the same room or share food.

When providing necessary assistance (supplies), both parties should adopt adequate protection measures including wearing a mask, maintaining social distancing and minimizing the duration of contact.

- You are allowed to go out provided that you show no symptoms, but only to engage in limited activities.
- You are not allowed to take public transport or visit crowded places (such as hypermarkets, department stores, night markets, nightclubs, bars, wedding banquets, restaurants, tourist attractions and so on).
- Postpone non-urgent medical treatment or check-ups.
- Observe name-based registration and keep a record of what you do on a daily basis. Masks and social distancing are mandatory at all times.
- Do a self-paid at-home rapid test on the 3rd and 7th day during enhanced self-management.

Self-health Management

- Record your body temperature in the morning and evening, as well as health conditions and activities.
 Respond to text messages regarding your health conditions.
- All information is uploaded to the National Health Insurance Medi-Cloud system to remind the medical personnel to implement the "TOCC" mechanism.
- Avoid visiting places where social distancing cannot be maintained or where you are in close proximity of non-specitic people.
- You are prohibited from engaging in close or cluster activities with other individuals (such as having meals together, gatherings, public gatherings and so on).
- Wear a mask and maintain social distancing when going out.
- Postpone non-urgent medical treatment or checkups.
 You are prohibited from visiting any hospitalized individuals.
- Contact your local Department of Health or call 1922 should you exhibit any symptoms and follow the instructions on seeking medical attention.
